- 2. Associate membership is open to bodies that produce and promote theatrical works for performance to the public but do not satisfy the criteria set out above. Associate Members are entitled to all the benefits of membership of NODA other than the right to vote at General Meetings. In addition, they may be subject to the discretion of NODA Insurance in relation to the cover to be provided and the premium to be charged.
- 3. Schools, Colleges and University membership is open to any educational institution, whether state or independent, that provides and offers education where the performing arts form part of the broader curriculum.
- 4. The election and rejection of members rests with the relevant Regional Committee. Your membership will be considered provisional until approved by the Regional Committee.
