# Terms and Conditions

## Important notices

National Operatic and Dramatic Association is registered with the Information Commissioner and abides by the Data Protection Act 1998. Under the terms of the Data Protection Act, we are obliged to have the personal consent of members that they are happy for NODA to circulate their details amongst the membership or to members of the public enquiring about societies and performances in their area.

## Individual and joint members

- This form has been sent to the address we currently hold for you. If you need to change any of the contact details we hold for you, please update them by logging into your account on the NODA website, emailing the changes to [info@noda.org.uk](mailto:info@noda.org.uk) or complete the form overleaf, as necessary, and return it to us.
  - The Gift Aid Scheme allows us to treat individual and joint member subscriptions as Gift Aid donations. This means we can reclaim 25p in tax from the Inland Revenue for every £1 that you donate. If you pay tax at the higher rate, you can claim further tax relief in your self assessment tax return. Members must have paid enough income tax and/or capital gains tax to cover the amount that NODA will reclaim for this tax year. Council tax and VAT do not count.
  - Individual and joint members can pay their annual subscription by Direct Debit. This simplifies collection both for the member, by removing the need for you to write a cheque each year, and for NODA, by ensuring that your membership renewal takes immediate effect from 1 January. Collection will take place on, or around, 5 January each year. Please complete the Direct Debit form enclosed to pay by Direct Debit.
  - **The Direct Debit form must be returned by 20 December 2018** in order to process the application for 2019 membership.
