Please read these **IMPORTANT NOTES** below and overleaf before completing the form

- NODA Pantomimes can only grant permission for the script to be recorded as agents for the author. It does not allow you to video record shows without the prior agreement of any paid performers, musicians, stage staff and the like (assuming all amateurs agree to the recording). In particular, it does not convey any permission to video record copyright music.
- A Licence from NODA Pantomimes only permits you to make a video/DVD recording and copy from it for the private retention of members of the society. It does not grant permission for public sales or screenings of such video recordings, including video sharing sites such as YouTube, Facebook or similar. There is no exclusion, even for charitable purposes although screenings in hospitals, residential homes and the like where no charge is made, are exempted. Copies of the master recording (or copies of copies) **may not** be sold to the general public.

- Any recordings produced must under no circumstances be sold commercially. Any copies can only be issued to cast members on a non-commercial basis for private viewing only and are not to be uploaded to any internet video sharing sites e.g. YouTube, Facebook or similar.
- Should any infringement come to the attention of NODA, we reserve the right to take action where it is deemed necessary to protect our rights under the copyright act and as pantomime agents.
