heartache, not to mention work and expense that that entails. COVID 19 has certainly had a profound effect on all our lives

That said, there have been some good and positive things to have taken root. They do say that necessity is the mother of invention and how well that has been proven over the last 18 months by individuals and societies alike!

I would like to start by thanking our Head Office team, who, of course, have been working from home, but still encouraging and supporting members, and council members, with lots of help and assistance (and patience) on all kinds of issues. However, the technical aspect does spring to mind, with a virtual Summer School in 2020, and another one arranged for 2021, and a virtual Volunteers Conference – Valuing our Volunteers. Initially societies arranged quizzes, play readings and general get-togethers online, proceeding to virtual performances. The whole thing being live streamed as well to a socially distanced audience. A real tribute to every single member of the group – with a special mention to the 'techies' who put together and synced the whole production – superb!

At the same time, we know of several societies who have taken the opportunity to review their own policies and procedures, and perhaps undertake some additional training (provided by NODA of course) – all essential stuff but sometimes finding the time to do this can be an issue. Personally, many of us have become very experienced (perhaps more than we would have wished) at Zoom meetings. Report of the Trustees for the Annual General Meeting of the National Operatic and Dramatic Association Charitable Incorporated Organisation Charity No. 1171216

This Report covers the 12 months to 31 December 2020. The over-riding strategy in the year has been to be proactive in making contact with members, to offer and provide increased direct support as well as continuing to explore opportunities for mutually beneficial joint working arrangements.

The pandemic curtailed all activities of the association and its members with all venues closed to public performance from March 2020. Our usual programme of visits to member societies and show reports did not take place. In May and June, we put online a number of training videos/courses which were available to all members. The demands on Head Office for advice on performances was intense and we lobbied the appropriate government departments championing the cause of Amateur Theatre.

As announced at the last AGM, the 2020 subscriptions were extended to 31 March 2021, to redress some of the reduction in service. We anticipate 2021 subscription income to be somewhat lower than in 2020, and have budgeted accordingly.

Our trading subsidiary has been affected by the pandemic with income from royalties and awards being almost nil from March of 2020. Insurance commissions have been affected, but not as severely as other trading activities. Societies still require to insure their assets and continue with their public liability insurances. NODA Insurance has been positively supportive of insured societies pursuing abandonment claims during this difficult period.

Vision

Going forward we have been working on plans to ensure that the vision for the NODA is that amateur theatre is successful and sustainable, providing a range of opportunities for people to develop their skills, and ensure enjoyment taking part in theatre, at all levels, can be achieved.

Mission

NODA's mission is to support the education and information needs of individuals and organisations, with high quality services and products that contribute to the success of amateur theatre, as well as encouraging appreciation of the sector by participants and audiences alike.

We aim to:

- Give a shared voice to the amateur theatre sector.
- Help amateur societies and individuals achieve the highest standards of best practice and performance.
- Provide leadership and advice to enable the amateur theatre sector to tackle the challenges and opportunities of the 21st century.

NODA structure

NODA has an elected council, comprising 11 councillors, the Chairman and President and two life members, who have been Past Presidents. Because the presidential term was extended to two years, the Vice President was co-opted to Council. Each councillor represents a region, and each region has a committee which, through its network of Regional Representatives, provide a vital link to the association's grass roots working with societies to sustain and promote amateur theatre in their part of the country. We started the year with five staff members at our Head Office based in Peterborough. With the reduced activity during 2020, two were furloughed for much of the year.



Chairman's Report Michael Hastilow

The report for 2020 is for a twelve month period. With lockdown commencing in March, most of the face to face activities of the association were curtailed. Council and its sub-committees have met regularly, courtesy of Zoom.

The number of staff at Head Office remained unchanged during

2020, however following the lockdown in March 2020, and the cessation of normal theatrical activity by member societies, there was little work for Beverly and Richard to undertake and they were furloughed for large portions of the year. Richard made the decision to retire and left us in February 2021 and Beverly left us on 4th January 2021. Rob Williams and Dale Freeman have worked closely to deal with the difficulties societies encountered as we progressed through the pandemic. Initially it was abandonment, the deferment of licences as planned performance dates came and went, and then the interpretation of differing rules in each of the devolved regions.

Achievements and Performance

- The benefit of social media was utilised to cover all aspects of NODA's activities and to keep us in touch.
- Members continued to use the Legal Helpline to their advantage.
- NODA Safe advice line continues to be utilised by members for both specific and general health and safety issues. We have introduced a series of accessible online courses on the safe use of equipment on stage and we have produced a freely available checklist for a safe return to rehearsal and performance.
- Fact Sheets are still a sound source of information for members.
- Newsletters are circulated at regular intervals.
- NODA Today has continued the format of incorporating articles from regions into the whole, making for more interesting reading.
- Improvements to our website are almost complete.

We have reviewed our pantomime portfolio, removing many outmoded scripts and introducing new ones. The Panto Scripts website is now operational.

NODA Theatre Summer School

To many this is the jewel in our crown. It provides the association with a vehicle with which to meet its educational objectives. The residential theatre summer school in 2020, had to be replaced with an e-summer school. It was successful although it lacked the personal interaction so valuable to students. The school for 2021, took a similar format. Discussions are in an advanced state for a residential school for 2022 under the directorship of Sarah Osborne. A number of bursaries will be available to make the school more affordable to members of member societies.

National Conference

NODA's National AGM & Presidential Gala planned for 2020, was postponed and the presidential term was extended by a year. The AGM was held virtually and attracted a larger attendance than in past years.

Regional Conferences

In 2020 only two regions were able to hold their conferences before lockdown was imposed. The regional AGMs and conferences held subsequentially were virtual.

Advice, representation and recognition

NODA continues to provide advice both on a one to one basis or through its published fact sheets. The NODA Legal helpline is provided by Counterculture LLP and Health and Safety Advice by NODA Safe. All are used on a regular basis by members. 763 long service awards, including youth awards and certificates were made in 2020, compared with 1,252 in 2019. NODA awards are in recognition to service in the dramatic arts and are available to all members of NODA affiliated societies. For those who do not meet the criteria for a long service award, such as paid officials, NODA does offer a commendation award.

Website

The website continues to be improved and offers access to an increasing range of information and services.

The pantomime web page (Panto Scripts) is now live and it is possible to examine scripts, order perusal copies and complete licensing arrangements all online,

The website had 252,733 visits in 2020, compared with 385,000 visits in 2019. A reflection of the effect of the pandemic on NODA and our members activity.

Programme and Poster Competition

Each region holds its own Programme and Poster competition, all to the same rules as published on the website, with the winning entry in each category going forward to the national competition. The national winners and runners up for 2019, were announced at the National AGM in September 2020. The awards will be presented this year 2021. The rules for the competition have been reviewed and the new criteria will be effective for programmes and posters for productions taking place from 1 January 2022.

COVID-19 and 2020

The pandemic has overshadowed all our activities since March 2020, and has resulted in a different way of working as highlighted in the Trustees Report. With the relaxation of the rules, and with an eye to the safety of members and audiences, we hope to see a gradual return to a more normal level of activity. It will not be until 2022, that we will see a full return.

Fundraising

No national fundraising initiatives were undertaken in 2019.

Finance Report (2020)

The Consolidated Accounts (audited by MHA Macintyre Hudson) have been prepared in accordance with applicable law and United Kingdom Accounting Standards including Financial Reporting Standard (FRS) 102 'The Financial Reporting Standard applicable to the UK and Republic of Ireland' (United Kingdom Generally Accepted Accounting Practice).

The audited accounts were approved by Council on 26th June 2021, copies are available from the Peterborough Head Office. The accounts cover the twelve months to 31 December 2020, the comparative figures cover the twelve months to 31st December 2019.

Income for the year (including £15,844 from investments) is £540,532 compared to £861,280 for 2019. The cost of running the association amounts to £475,109 (2019 £791,589) giving a surplus before gains or losses in investment values of £65,423 (2019 £69,682). At 31st December 2019, a revaluation of our investments showed an unrealised loss in value of £27,381 (2019 a gain of £41,201)

Profit from NODA Ltd was £56,239 for 12 months to 31 December 2020, compared with £122,592 in 2019. The profits of NODA Ltd are donated via gift aid to NODA (the charity).

- Trading Subsidiary (NODA Ltd). The profit achieved in the year is considerably less than the amount budgeted.
- Insurance commissions of £119,790 were received in the year.
- Investment income of £15,844 is marginally below our budgeted expectations for the year.

- Governance costs, although no longer require to be shown separately, were £27,761. (In 2019 £43,287).
- National Conference was held virually in 2020, the net cost was £7,012 (2019 £20,303)
- Regional conferences/events. This category includes regional conferences, regional and district awards, regional workshops and district meetings. The overall net cost for 2020, was £12,280 and compares with £24,042 for 2019.
- Summer School, in 2020, held as an e-school, the net costs of Summer School £21,020 (2019 £36,898),
- Publishing Print and Electronic Newsletters and Magazine spend was £48,427 (2019 £57,061.)

The "Summary Consolidated Statement of Financial Activities" and the "Summary Balance Sheet" included in this review for the year ended 31 December 2020, are extracted from the NODA consolidated accounts, copies of which may be obtained from the NODA Head Office in Peterborough.

Council are therefore reporting that, at 31 December 2019, the net consolidated worth of NODA CIO, your association, was £1,108,504 (2019 £1,070,462) and Council recommend the adoption of these accounts at the AGM on 11th September 2021.

Council propose that this report will be taken as read at the AGM, but that questions will be invited to be submitted either prior to the AGM (preferred) or from the floor at the AGM.
