Report of the Trustees for the First General Meeting of the National Operatic and Dramatic Association (NODA CIO)

The Charitable Incorporated Organisation was incorporated and registered by the Charity Commission on 20th January 2017.

Within 15 months of incorporation NODA CIO is required to hold an Annual General Meeting, thereafter they must be held within 15 months of the previous Annual General Meeting.

The meeting convened for 23rd September 2017 meets the requirement and puts us on track for 2018.

At an extraordinary general meeting of its sister organisation (NODA Association) a resolution was passed that the entire undertaking of NODA Association be transferred to NODA CIO with effect from 1 May 2017 on which date NODA CIO accepted the membership of

management of risk, logistics, box office versus costs of production and the increase in leaislation and pressure by our venues to recoup lost local and government subsidies.

We strive to put the membership in the best position possible but you do have to participate by looking at our factsheets and following the guides on risk assessment and risk management. Most regions run workshops, nationally we run the NODA Theatre Summer School where the ethos is teaching you a skill whilst still having fun, it is up to our membership to take advantage of these offerings.

This report concludes my year as President, as eventful a year as one would not readily wish to experience but one which I have much to be grateful for. I have seen the final moves from unincorporated body to a charitable incorporated organisation, on a personal level I have visited most Regions, seen productions of all genres met with a very enthusiastic and hardworking membership I have seen new staff installed at HQ and a feeling that we are all pulling in the same direction, I have seen the final thrust in getting our new web site up and running and I have seen a surplus on operating costs, all positives and so I end my report with the exhortation to keep up the good work.

Founded in 1899 "to protect and advance the interests of operatic and dramatic art, and of societies engaged therein", our membership continues with 2053 society members and 999 individual enthusiasts individual enthusiasts staging musicals, operas, plays, concerts and pantomimes in venues ranging from the country's leading professional theatres to village halls.

NODA structure

Each of NODA's 11 regions is headed by a Councillor who sits on the ruling body of the Association (the National Council). In turn, they are supported by a network of regional representatives and committee members who provide a vital link to the grass roots of the association. NODA is administered from the registered head office in Peterborough by knowledgeable and friendly staff.

Highlights

- ★ The Association became a Charitable Incorporated Organisation
- ★ The new membership database which went live in October 2015 has improved our contact with members. Investment continues in developing a new website to be launched in September 2017.
- ★ NODA's National AGM and Presidential Gala took place at the Hilton Birmingham Metropole on 24th September 2016
- ★ Over 200 students attended the 2016 Summer School which featured 15 courses in a variety of disciplines. This was the final year of Summer School being held at the University of Warwick and a new venue was used for 2017.

Chairman's report John W. Barnes

2016 was very much a year of change with the departure of the CEO and 4 other members of the Headquarters' staff, including the resignation of Fred Piggford as Chairman of NODA on health grounds, soon after the 2016 AGM at Birmingham. I stepped into the role as

Interim Chairman of NODA from November 2016.

The services we provide to our members is a very important part of our work, and this we managed to ensure continued despite the changes.



Achievements and Performance

NODA continued to work towards the 5-year strategic plan introduced in January 2013 and explore the potential to improve services to members:

- ★ Health and Safety Advice line called NODA Safe continued to offer on line resources as well as workshop training and a telephone/ email advice line;
- ★ The on-line First Aid training for members continued to be available;
- ★ The use of social media by NODA, with an increased use of Twitter and Facebook, continued to prove more effective than ever. During the year it was noted that for the first time, email and online contact between NODA members and the Peterborough based staff was greater than contact by telephone;
- ★ Regular newsletters were issued to its members;
- ★ Investment continued in developing a new website;
- ★ Increase in informal advice and guidance was provided by the professional staff team on a range of commercial and contractual issues.

NODA Theatre Summer School

As part of its Education and Training programme and in line with its educational objective, NODA continued with the residential Theatre Summer School, held from 30th July to 6th August at the University of Warwick. This was the last year that the school could be held at Warwick due to being unable to host NODA in 2017 & 2018 and a new venue was negotiated. The provision of bursaries by NODA is an essential component of the success of this event, giving people who would otherwise be unable to afford it, the opportunity to increase their knowledge and skills with professional tutors.

Courses in all area of theatre and off-staff disciplines such as burlesque, video production, Stage combat, stage management, sound design and costume design were held, to name but a few.

National Conference

NODA's National AGM and Presidential Gala took place at The Hilton Birmingham Metropole on 24th September 2016; we were delighted to have the presence of our Patron, Connie Fisher and Colm Moules, President of the Association of Irish Musical Societies, with first class entertainment by West Bromwich Operatic Society and WBOS Youth Theatre.



Regional Conferences

All regions held their own conference during the year. These varied from one to three-day events, dependent upon the support within the region. Nine of the eleven regions incorporated a performance awards scheme, normally as part of the Regional AGM event, to encourage improved performance standards by their member societies.

Most Regions held workshops in both technical and performance skills thus enhancing the competence of NODA members. Many of these involved youth, which NODA is very keen to increase and promote throughout the country.

All regions held many networking events, either evening or afternoon meetings, each covering one or more districts, the prime purpose being to disseminate information to members, receive feedback and statements of need from members, as well as encouraging networking between members and societies.

Advice, representation and recognition

NODA continued to play a vital role as an advocacy body with the provision of the NODA Legal Helpline, provided by Counterculture LLP, and the Health and Safety Advice line, as well as the provision of Fact Sheets.

1,913 long service awards including youth awards and certificates were issued compared with 1,794 during 2015, to recognise their contribution to amateur theatre. NODA awards are available to all NODA affiliated societies to present to their own members or members can apply through their society.

Magazine

NODA Today was published twice during 2016. Highlights included news on former members of an amateur society getting parts in the professional field after their hard work at drama schools, students sharing their experiences of NODA Theatre Summer School, NODA societies' involvement with the RSC's "Open Stages", as well as the regular roundup from Regions celebrating members' long service, exceptional performances and societies reaching their centenary or other milestones.

Website

The website continues to offer access to a range of information and services, including online access to pantomime scripts, a special discount code for members to book top attractions all over the UK. The website also offers the facility to book on line for the NODA Theatre Summer School, and to join or renew membership of the Association.

The website had 280,697 visits in 2016 compared with 274,552 visits in 2015; the number of visits has risen from 123,093 in 2009. Number of individual visitors was 175,955 compared with 167,651 in 2015.

Programme & Poster Competition

Each Region held its own programme and poster competition, winning entries going forward to the national competition. The national awards ceremony was held at the National AGM in September.

Fundraising

There were no national fundraising initiatives this year.

Finance report

The Consolidated Accounts (audited by MHA MacIntyre Hudson) are prepared to conform to SORP (Statement of Recommended Practice) as required by the Charity Commission and incorporate the changes required by the implementation of FRS 102 (Financial Reporting Standard).

The audited accounts were approved by of Council on 26th August 2017 and copies are available from the Peterborough Head Office.

We are reporting an operating surplus for the 16 months ending 30th April 2017 of £25,723 (2015 loss of £84,818) plus a surplus on revaluation of investments of £48,485 (2015 loss of £18,627) to give a total surplus in the period to 30 April 2017 of £74,208 (2015 loss £103,445).

Profit from NODA Ltd increased to £113,606 for the period to 30 April 2017 compared to £80,524 for the year 2015 equivalent to an annual increase of 5.8%. The profits from NODA Ltd are donated via gift aid to NODA (the Charity).

- ★ Trading subsidiary (NODA Ltd.) As stated above the profit from NODA Ltd increased by 5.8% in the period compared to the year 2015 although the gross sales income was down by 8.7%.
- ★ Insurance commission of £186,689 received in the period included a profit share of £29,851 indicating that the campaign (in cooperation with NODA Insurances and NODA Safe) to promote safe working in Amateur Theatre continues to have a positive effect.
- ★ Investment income. This was reduced in this extended period to £26,321 compared to 2015 (£32,835) due to withdrawals of



investments used to support previous years activities.

- ★ National Conference in 2016, the net cost of the conference was £21,864 compared with costs of £17,302 in 2015.
- ★ Regional Conferences/events. This category includes regional conferences, regional awards, regional workshops and district meetings. The overall net costs of regional events in the period was £45,350 compared with £39,590 in 2015.
- ★ Summer School. The net costs of Summer School amounted to £27,109 (£24,004 2015) being bursary support and allocated administration costs.
- ★ Publishing, Print and electronic newsletters and magazines spend has increased to £63,766 compared to £ 56,068 in 2015.
- ★ Governance Costs in the period amount to £70,166 compared to £52,886 in 2015.

The "Summary Consolidated statement of financial activities" and the "Summary balance sheet included in this Review of the period to 30 April 2017 are extracted from NODA Consolidated Accounts which will be available on the NODA website.

Council are therefore reporting at the end of April 2017 that the net worth of NODA , your Association, was \pounds 889,729 and Council recommend the adoption of these accounts at the AGM on September 23rd 2017.

Council propose that this report will be taken as read at the AGM but that questions will be invited to be submitted either prior to the AGM (preferred) or from the floor of the AGM.
